

Promo Mechanics

- 1. The SM Store Holiday Promo is open to all Metrobank Peso Visa/Mastercard, Femme Visa, Femme Signature Visa, Travel Platinum Visa, Platinum Mastercard, World Mastercard, PSBank Credit Mastercard and Toyota Mastercard cardholders in good credit standing. The promotion is not applicable to Metrobank ON Internet Mastercard, Metrobank Dollar Mastercard, YAZZ Prepaid Visa, Metrobank Prepaid and Debit cards.
- 2. The promo period is from October 15 to December 31, 2018.
- 3. Cardholders who shop at The SM Store for a minimum single-receipt 0% installment spend of P15,000 will get a free P500 eGift.
- 4. The P500 eGift can be exchanged for P500 worth of SM Gift Passes.
- 5. Only 0% interest installment purchases on 3 and 6 months tenor are qualified for the promo.
- 6. This promo is also available to Shop Now, Pay Later (SNPL) up to 90 days.
- 7. Cardholders who meet the qualified purchase at The SM Store will receive an eGift code via SMS. To redeem, cardholders should present the SMS at the Customer Service of any The SM Store branch.
- 8. Redemption period for the free eGifts is from October 26, 2018 until March 01, 2019, or not later than sixty (60) calendar days from the end of the promo period. All unredeemed eGift code(s) will be forfeited after the expiration date indicated in the SMS.
- 9. The eGift code(s) cannot be exchanged for cash, other products or discounts.
- 10. MCC will no longer accommodate cardholder in re-sending requests for eGift code(s) such as, but not limited to the following reasons:
 - eGift code(s) sent successfully to the principal cardholder but were accidentally deleted by the cardholder, members of their family or friends or due to upgrade or reformatting done to the cardholder's mobile device;
 - b. Due to lost, stolen or defective mobile device;
 - c. eGift code (s) sent successfully to the principal cardholder's registered mobile number maintained in MCC's database during the promo and redemption period.

Should the principal cardholder request for a change in his mobile number during the promo period, only succeeding eGift codes earned will be sent to the new mobile number.

- 11. Splitting of transactions is prohibited and shall not be allowed for redemption. Splitting is defined as an intentional act of dividing a merchant installment transaction into multiple charge slips to redeem more than one reward incentive. Presumption of split transactions is having 2 or more transactions in one merchant outlet or establishment over one and the same product, and the interval of these transactions were made within 5-10 minutes.
- 12. Should it be proven that a cardholder was able to redeem the free P500 eGift without adhering to the above mechanics, the cost of the eGift will be charged by MCC to the cardholder's credit card account.
- 13. All installment purchases are subject to the Terms and Conditions governing the issuance and use of Metrobank Cards and all related provisions of Metrobank Card's 0% installment program.
- 14. All 0% installment purchase/s are subject to Metrobank Card's approval and only valid if monthly dues are paid in full.
- 15. The promotion is not valid in conjunction with other The SM Store and Metrobank Card offers.
